



The 'Big Picture'

Socio-economic, political and cultural context

Persons of all backgrounds affected

- Rates highest among Whites, older adults
- Anticipate minority groups will be increasingly affected (must ensure equal access to treatment)
- Need to reach youth before they develop dependencies
- Women of child-bearing age and infants especially vulnerable (NAS)

Rationale

55 (3.4/100k)

- Opioid overdose deaths, County residents, 2016

241 (14.8/100k)

- Opioid overdose hospitalizations, Sacramento, 2016

1,188,824 (735.3/1k)

- Opioid prescription dispensed to County residents, 2015

The 'Big Picture' continued

Key activities

1. Facilitate safe disposal
2. Expand public education and media outreach
3. Engage the medical community/address supply
4. Promote early intervention treatment and recovery
5. Prevent overdoses, including overdose deaths
6. Enhance opioid surveillance, epidemiology and evaluation

Why a Coalition?

Advisory Board

- body that provides non-binding strategic advice

Task Force

- a single-resource unit assembled to meet a specific tactical need

Committee

- a group of people appointed for a specific function

Coalition

- an alliance of **combined action**





COSN Examples:

Health Professionals	You are the gatekeepers and primary contact for community members at risk for SUD, we need your expertise and connections to reduce opioid overdoses through supporting safer prescribing guidelines, and increasing access to MAT and availability of Naloxone.
Law Enforcement/ First Responders	Law enforcement and first responders have a critical role in saving lives and keeping our communities safe from the fallout of this epidemic.
